

LAWFUL DECLARATION OF TRUTH AND COMMERCIAL NOTICE

Reservation of Rights

I, Joshua-James; Erskine, a living man created by the Most High, not a corporate fiction, not an entity, and not subject to foreign jurisdiction, hereby reserve all rights, nunc pro tunc, ab initio, under:

- God's Law (Natural Law)
- The original Constitution for the united States of America
- The Bill of Rights
- UCC 1-308 and UCC 1-103.6

Any statute, code, mandate, or instrument in conflict with these is null and void. I stand in private ecclesiastical and lawful jurisdiction as a peaceful man with full capacity to testify to the truth.

Affidavit of Truth

I, Joshua-James; Erskine, do declare and affirm under the laws of God, the United States of America, and all lawful authority, the following statements to be true, correct, and personally known to me:

Statement of Facts

1. I have been and continue to be under what appears to be constant and unlawful surveillance, including while within my home, others' homes, and in sacred private areas such as bathrooms. This is a violation of sexual dignity, bodily autonomy, and spiritual sanctuary, and rises to the level of a criminal sex offense.

I demand that sex crime charges be pursued under applicable law against all persons—known or unknown—who engage in, aid, or allow this unlawful voyeurism. (Violations include: 18 U.S.C. §§ 2241–2246)

2. On February 6, 2025, my automobile was unlawfully seized by armed individuals identifying as government actors: Jason, Mark, Loria, and Raheem Akeem Barret. These individuals acted under color of law and authority, with no valid warrant, no due process, and no contractual agreement. This constitutes armed robbery, unlawful seizure, and coercion, and I believe it to be coordinated by parties involved in the ongoing surveillance.

3. It is my deeply held belief that Jerry James; Erskine and Lorraine Erskine are participants in the conspiracy against me, with actions and omissions supporting the unlawful monitoring and deprivation of rights.

4. I have lawfully submitted notice and requests for redress to: the Federal Bureau of Investigation (FBI), the Office of Inspector General, the Utah Attorney General, and the local police department. All have failed to investigate or act, constituting tacit approval, dishonor, and breach of oath.

5. The events and tactics used against me constitute multiple criminal violations, including but not limited to:

- 18 U.S.C. § 1581 – Peonage
- 18 U.S.C. § 1201 – Kidnapping
- 18 U.S.C. § 113 – Assault
- 18 U.S.C. § 241 – Conspiracy against Rights
- 18 U.S.C. § 242 – Deprivation of Rights under Color of Law

6. I am a peaceful, native-born man, operating always by the principle: "No harm, no foul." However, harm has been done—repeatedly and deliberately—and I now invoke my sacred motto:

"Fiat Justitia Ruat Caelum" (Let justice be done though the heavens fall.)

Notice to Agents is Notice to Principals

Let this stand as public record and commercial declaration. All actors who:

- Remain silent,
- Fail to investigate,
- Refuse to intervene,
- Or continue to participate in these conspiracies,

...are now commercially and criminally liable in both private and official capacities. Liability includes but is not limited to: financial restitution, civil penalties, equitable injunctions, and public censure.

Honor Clause

Failure to rebut this affidavit point by point within twenty-one (21) days, or acting upon this information and ceasing all actions by any actors named or unnamed, shall constitute standing in honor for the entirety of this document.

I, Joshua-James; Erskine, a living man, do hereby declare under penalty of perjury under the laws of the United States of America, that the foregoing is true, correct, and complete to the best of my firsthand knowledge, experience, and belief.
